As Irish voters head to the polls, GP Dr Tiernan Murray reveals that under current abortion laws he's prevented from giving pregnant patients the treatment they need, in case the foetus is harmed

THE young woman sitting in my office had cancer - yet, despite my best wishes, I had no choice but to deny her life-saving

treatment.

Her best option would have been radiotherapy, but she was pregnant and, because in Irish law the foetus is equal to a woman's life, this treatment could not be given to her.



Doctor Tiernan Murray has had to refuse treatments to pregnant patients with cancer because of Ireland's abortion laws

Pregnant women with cancer can't have certain scans and there are large numbers of drugs, including antibiotics, they aren't allowed so her chance of surviving was severely diminished.

It was one of the most difficult cases I've had in my career as a GP.

I'm a representative of Doctors Together For Yes – and thousands of doctors and nurses like me will be voting Yes to repealing antiabortion laws in today's referendum.

We want abortion to be legal in Ireland so that we can help women in need as the Eighth Amendment - which rules that the lives of unborn babies are equal to the lives of their mothers - stops me from doing my job. MORE FROM THE

We can't do anything for women in a crisis pregnancy

I had another young patient whose foetus was developing without a brain or a skull and would die within a short period of time after it's born. The death rate is 100 per cent.

I had to tell this woman that she'd have to go through the pregnancy, deliver the baby, and watch it die – or go to England for a termination, which costs thousands of pounds.

Plus, if the woman wants to bring her baby's body home for a burial, she has to pay to come home on the ferry with it in a little coffin.

I had a patient who was 42-years-old when she got pregnant. Her husband was an unemployed alcoholic, so they had financial struggles.

She had one child with Down's syndrome and one with autism and told me that she couldn't continue with this pregnancy - but she had to.

Another woman with severe diabetes came to me when she became pregnant but I couldn't give her some of the medication she needed because it might harm the baby.

Her care was reduced and she could have gone blind from diabetes.

Under current Irish law, a woman who has been raped and has an abortion illegally could technically face more jail time than the man who raped her. That's shocking.

Doctors are legally obliged to report women who they believe are planning to have an abortion.

It is a crime to aid a woman in procuring an abortion, punishable by up to 14 years for the woman or the doctor.

Despite this, thousands of women a year are buying and using illegal abortion pills (6,000 pills were seized by the police in Ireland

Pro-choice campaigners want to repeal the Eighth Amendment, which rules that the lives of unborn babies and mothers are equal

Websites like Women on Web provide women with safe medication and consultation, so most women get their abortion pills on there. They usually cost below £85.

Although the World Health Organisation says they're safe, there will be cases where things go wrong.

There will be some women who can't take the pills, such as those with other medical conditions.

If a woman is bleeding, scared, or doesn't think the abortion has happened properly, she can't see a doctor or tell hospital staff without admitting she's broken the law.

My job is not to make decisions for people, it's to deliver a service. So, for these women, I can't do what they want, or what is best for them. It's tragic.

There are also cases when women have died as a result of doctors' inaction, such as Savita Halappanavar.

She was about 17 weeks pregnant and was miscarrying but there was still a heartbeat so the doctor could not do the abortion that would save her life.

Savita died shortly after from sepsis.
